# REPORTS OF COMMITTEES

# a. TRU Sustainability Education in the Curriculum Sub-Committee – No Report by James Gordon

**Action Item:** James will reach out to Crystal Huscroft, Chair, and ask her to join the meetings and provide a report.

# **b. Awards Sub-Committee** – Report by Chris Adam and Brad Harasymchuk

Brad, Chris, James, and Scott met and explored the possibility of moving the awards to the President Awards. They also made recommendations to:

- make the awards more prestigious.
- revise the documentation for clarity.
- review the structure and quorum.
- move deadlines.
- update content and photos on website and social media sites including Instagram.
- a. ESAC Zero Waste Sub-Committee No Report by James Gordon and Anna Rogers. Next meeting for Sub-Committee is scheduled for October.

James reported on the pilot project of the garbage compounds at McGill and East Village. The compounds are more centralized and locked to make waste management practices safer and more accessible to students.

A request for proposal to hire a Zero Waste consultant for 3-year contract will be award by October 31, 2022. We have received two submissions which are being reviewed, and we look forward to additional expertise and best practices.

Anna Rogers mentioned data collection is being streamlined where a tablet is being used at the Warehouse to submit weights of various waste streams via an online form that auto populates a master spreadsheet.

Anna is engaging volunteers to capture location of recycling bins and to re-evaluate the logistics of the locations.

Anna will conduct waste and brand audits to identify the source of disposed garbage.

Anna is looking to provide recycling educational information to students.

Anna provided a summary of key takeaways from the Zero Waste Conference she attended in Vancouver on September 28 and 29. These included the importance of:

#### Advancing a Circular Economy

- Current economy is still linear. Materials are taken from the Earth and turned into products that eventually get thrown away as waste. Advancing a circular economy requires rethinking design in a way that eliminates waste and pollution from the start, circulates products and materials at their highest value so they do not become waste, and facilitates regeneration of resources rather than extracting them.
- Rather than focusing on doing less harm to nature we must focus on actively improving it. This requires experimenting with totally new ways of doing things.

### • Transforming Business Models (A few examples)

- TriCycle is fighting food waste by feeding insects with by-products from the agri-food sector, turning the insects into a high protein and vitamin food for people, and using insect manure as an organic fertilizer to nourish the earth.
- UNLESS Collective makes plant-based clothing that can withstand the elements. At end of life their clothing can be decomposed to make new plants for the future.
- Building industry is starting to explore ways to create buildings that are living, regenerative, restorative, and adaptive by design (e.g., biomimetic architecture).

#### • SHIFTing Behaviors

- Everyone has a role to play in achieving zerowaste. The SHIFT framework distills global, evidence-based practices in marketing, psychology, and behavioral economics into a practical tool for encouraging eco-conscious consumer behaviors.
- Social Influence people engage in behaviors that are widely socially approved.
- Habit Formation making sustainable choices easier and automatic.
- Individual Self appeal to people's core values, motivations, norms, and self-interests.
- Feelings and Cognition tap into people's thoughts and feelings through information and experiences.
- Tangibility make things real, substantial, concrete, and easy to imagine.

The Committee reports annually on mission fulfillment related to sustainability and meeting the annual and 5-year targets. Percent of mission fulfillment was 86%, but we did not meet carbon target.

Dashboard reports are a process to track targets and reflect if outcomes show improvements.

Subcommittee will meet again in November, and they are happy to have new members.
